SUBMISSIONS have been sent to:

* Blue Mountains City Council about Lawson Lodge. Precip: too large a population injection for available services or harmony in local society; insufficient preparation for environmental safeguards to prevent down-slope modifications.

* BMCC about Bass Street Wentworth Falls, Landcom subdivision. Precip: Unimaginative dissection of land with high natural environment values and a potential to create problems at the head of Jamison Creek.

* Civil Aviation about Radar Tower at Mt. Boyce. CAA advised it is an inappropriate proposal. Readers, do not confuse this with the radio tower at Kings Tableland.

* Roads & Traffic Authority - our comments sought on Landscape Plan for Woodford Bends. Answer is that it appears satisfactory but that Bull's Bath, 19th Century artefact, has been swallowed and needs to be regurgitated.

Radiata Plateau - Land Preservation monies are being held for the time being for reclamation of this land.

* Threatened Species Network. The Blue Mountains has a higher percentage of rare plants in its flora than most regions. The Society is pursuing the subject of a Threatened Species conservation Act in the NSW Parliament.

* A Development Control Plan of Strategic Fire Advantages and Fuel Management Plan for the Grose Catchment will be exhibited and your comment to Council is requested. A further plan will be prepared for the southern catchment. Do have a look when the plan is on show because most of us are at risk.

The Nature Conservation Council is a top environment body in NSW and represents the majority of regional conservation groups. The UBMCS is a member and through NCC also contributes towards the employment of a parliamentary lobbyist. The NCC conference in October will accept two proposals from the Society.

(1) from Wyn Jones : precip is that there be tax concessions for showing a degree of independence from the power grid by use of energy saving devices.

(2) from an idea of John Davies: in full: "that the Nature Conservation Council of NSW seek urgent additional commitments from the state and federal governments to significantly increase the rate of reforestation of cleared land with native timber species, particularly to establish woodlots on the Western Slopes and Tablelands of NSW in order to provide future assured supplies for the state of fuel

wood for rural communities, timber for Australian homes, honey production and an increase in biodiversity.

A greater degree of encouragement through regulatory mechanisms and financial incentive through low interest rate long term loans should be given to local communities and landholders involved in joint projects for woodlot establishment and the following specific means should be used to encourage their widespread acceptance in the community;

* through establishment of memorial forests to replace cemeteries,

* planting up large areas owned by public authorities,

* promoting reforestation of the Hawkesbury-Nepean catchment.

The Plant Sale is Saturday Nov.2nd, 9am. The stock has been checked over by the excellent people at the Hazelbrook Nursery and everything looks to be in fine fettle. Grete Vanry is contributing plants again. Those experienced in growing native plants in the Mountains will be there to discuss your particular requirements and to give advice on problems. Return of pots would be appreciated, particularly 6"diam (approx) and 2½" diam.x4½"(approx) sizes.

Seeds of local bush plants are always needed. The Blackheath Nursery is contracting to grow hundreds of a given species. There are only four people providing seed and it is unbelievable that the walkers of the Society are unobservant of the genesis of the bush. Not all the walks are in the national park. The Blackheath Nursery output will go to bush regeneration and rehabilitation. All the pea flowers and wattles are out now. Watch for ripening seed vessels and harvest. We need your help please.

Certificates of Achievement have been awarded to the Society by the City Council for taking part in Clean up Australia and Weeds Awareness Weeks. Thanks to those energetic people who laboured in the cause. It is the same people who turn up every time. With our number of members this is a very poor show.

VALE NANCY DOUGLASS

The editor is privileged to accept this obituary from past President Graham Alcorn. The continuity of the ideals of the Society is one of its strengths and Graham has given us a glimpse of the dedication of early members.

"A highly esteemed and valuable member of our Society, Nancy Douglass, died at Springwood Hospital on July 30 1991. A frail person, Nancy had an indomitable spirit which sustained her to the respectable age of seventy seven.

On September 7 an impressive and well attended memorial service was held at the Katoomba Cemetary where her ashes were interred in the grave of her husband Bob, a past president of the Society. We were represented by Winsome Gregory and myself, appropriately in that we are the only remaining members still in the Mountains of the old Land Use Committee for which Nancy worked so hard. Beryl Cooley lives in Sydney and Isobel Bowden, the great Blue Mountains ecologist and initiator of our policies has passed on. This committee was formed in 1973 when the draft Blue Mountains Town Plan was first displayed. We had the tasks of forming a policy to preserve the environment and co-ordinating the efforts of our members to compile a submission. Significantly it opens on the title page with the following : Spokesman: Mr.G.N.Alcorn, who will be supported by Mrs.N,Douglass. Correspondence: Mrs.N.Douglass. And what a pleasure and relief it was to have her.

Even to this day the main points of policy and the detailed submission still constitute the main steps necessary to secure the Blue Mountains environment. I feel that all the plans and strategies and enquiries that have been held since have been in the main subterfuges to avoid implementing our policy.

In the years that followed Nancy continued her unflagging vigilance. An account of her activities would fill a book, - Megalong Valley, Jamison Creek catchment, Leura Creek catchment, Kings Tableland and so on. She would phone and say, "Graham, we've got to go and look at this." Often, I'd say, "I think it's alright". "No Graham, it isn't". And always it wasn't. One day when we were feeling depressed with the activities of the council and the developers, Nancy wrote an article detailing our achievements - quite an impressive list. It will be somewhere in the Newsletter files.

I know that the splendid traditions of work initiated by the old Land Use Committee have been continued very capably by the subsequent and current officials of the Society. But I count it a rare privilege to have been associated with those great battlers of the 70's and the early 80's, not the least of these my dear friend Nancy Douglass.

Nancy's brother, Dr. Laurie Johnson, Director of the Sydney Botanic Gardens, made a fine oration at the memorial service. One impressive statement was to the effect that Nancy, who was not a religious person, was a splendid example of how it is possible to live a highly ethical life without promise of reward or fear of punishment."
