CONSTITUTION.

LOWER BLUE MOUNTAINS WILDLIFE CONSERVATION SOCIETY.

- Name : The Society shall be known as the "Lower Blue Mountains Wildlife Conservation Society."
- Aims : The aims of the Society shall be to : -
1. Educate the members and the community to the cultural values of nature.
 2. Work for the reservation of areas of natural environment for the refuge and breeding of indigenous flora and fauna.
 3. Carry out research into the distribution, population and species of flora and fauna in the Blue Mountains.
 4. Do any other thing from time to time decided in the pursuit of the above aims.
- Members : Membership shall be open to all.
- Subscriptions: Annual subscriptions shall be \$1-00 per adult , 20 cents per junior.
- Officers : President, Vice-President, Secretary, Treasurer, Publicity, Census.
- Meetings : Meetings shall be held once in each month. The Annual General Meeting shall be held in October.
- Quorum : Five members shall constitute a quorum at monthly meetings, and one third of the membership shall constitute a quorum at the Annual General Meeting.
- Executive : The Executive shall consist of the officers of the Society.
- Committees : The Executive may appoint from time to time Committees from among the members for purposes in accord with the aims of the Society. One standing Committee shall be set up, to carry out investigations into land use, protection and development.
